POLICY

The Registrar and/or Registration Committee of the College of Alberta Denturists pursuant to the *Health Professions Act* (HPA), the *Denturists Profession Regulation* and the Bylaws are responsible to review completed applications for registration as a regulated member. Upon receipt of a completed application, the Registrar and/or Registration Committee will consider the following in issuing a registration decision.

- 1. Status of application package
- 2. Review previous registration(s) considering any conditions that were imposed
- 3. How long it has been since the applicant last practiced the profession (application requirements may differ, at the discretion of the Registrar and/or Registration Committee depending on the time that has elapsed since the applicant was last registered as a denturist)
- 4. The number of practice hours that the applicant had accumulated in their previous practice
- 5. Where the applicant last practiced the profession
- 6. English language proficiency of the applicant
- 7. The conditions under which the applicant ceased to last practice
 - a. If the applicant left practice as a result of self-imposed leave, their application will be assessed based on the items listed above
 - b. If the applicant left practice due to a cancellation or suspension made under Part 4 of the HPA, the following must be considered:
 - i. Was the applicant's permit cancelled or suspended?
 - ii. Why was the applicant's permit cancelled or suspended?
 - iii. When was the applicant's permit cancelled or suspended?
- 8. Any other requirements deemed necessary by governing legislation, bylaws, or other policy.

If the applicant's practice permit was cancelled by orders of a Hearing Tribunal due to conduct that was considered sexual abuse, the Registrar and/or Registration Committee:

Must not grant registration to the applicant as per s. of the HPA

If the applicant's practice permit was suspended by orders of a Hearing Tribunal due to conduct that was considered sexual misconduct, the Registrar and/or Registration Committee:

- must be assured that the timing of reinstatement is in alignment with the orders of the Hearing Tribunal, and
- should registration be granted, must consider if conditions should be imposed on the member's practice permit to ensure safety of the public.

If the applicant's practice permit was cancelled by orders of a Hearing Tribunal due to conduct that was considered sexual misconduct, the Registrar and/or Registration Committee:



- must be assured that the mandatory five-year time frame since the date of the decision of the Hearing Tribunal, as mandated in s. 45(3) and 45(4) of the HPA has passed, and
- should the applicant have previously applied for reinstatement of registration, must be assured that at least six months has passed, as per s. 45(5) of the HPA, since their last application for reinstatement, and
- should registration be granted, must consider if conditions should be imposed on the member's practice permit to ensure safety of the public.

If the applicant's practice permit was cancelled by orders of a Hearing Tribunal under Part 4 of the HPA, the Registrar and/or Registration Committee:

- must be assured that the timing of reinstatement is in alignment with the requirements set out in the HPA and *Denturists Profession Regulation*,
- must be assured that the timing of reinstatement is in alignment with the orders of the Hearing Tribunal, and
- should registration be granted, must consider if conditions should be imposed on the member's practice permit to ensure safety of the public.

DEFINITIONS

Registration Committee: a statutory committee of the College which deliberates and makes registration decisions referred to it by the Registrar.
